

1. TRUST FUND: -

In Order to effectuate the said desire, the Trustees have made over to the trustees a sum of Rs.501/- (Rupees Five Hundred only) to hold the same together with all other properties that may be acquired out of the same or otherwise and may hereafter be subject to the trust (hereinafter referred to as trust fund) for the objects and purposes herein contained concerning the same.

- b. To open School of Nursing, College of Nursing, Pharmacy, Paramedical, Industrial training institute, Residential School, T.Ch., B.Ed., Teachers training college, B.B.M., M.B.A., Dental college, Diploma training college, Engineering, Law, Medical, Agriculture, Horticulture, Arts, Commerce & Science College and other educational institutions.
- c. To conduct health awareness programmes camp, organize camps blood donations camps, etc.
- d. To organize training camps in the filed industry agriculture, sericulture, agriculture, etc.
- e. To encourage fine arts and cultural activities in Music, Dance and Drama.
- f. For the purpose of the Trust may establish educational institutions of different kinds of different levels as and when they are required.
- g. To establishment libraries, hostels, boarding house free or otherwise to facilitate the promotion of student community.



- m. To make provision for research, advancement and disseminating of knowledge.

- o. To provide hostel facilities to the students, trainees, staffs, etc.
- p. To undertake projects/schemes/programmes of any kind and nature for the upliftment and development of the Trust irrespective of caste, creed or religion.
- q. To provide scholarships to deserving students.
- r. To establish run and/or to support in establishing and running hospitals, nursing homes, laboratories etc., with a view to serve the poor and the needy and also to further the cause to education and research in various branches.
- s. To diffuse useful education, literacy and social knowledge.

- u. To diffuse useful education, literacy and social knowledge.
- v. To arrange for the training in ancient Guru Kula system of education.
- w. To help the poor, orphans, physically and mentally handicapped people, widows and other disabled persons, by providing monetary or any other kind of assistance either by payment in cash or in kind supply or cloth, food, shelter, medical facilities and the like free of cost.
- x. To work for the welfare of people in villages for the development of social, environment and health aspects.

4.TRUSTEES TO RENDER TRUE ACCOUNTS: -

The trustees shall cause true and accurate accounts to be kept of all moneys received and spent and all materials in respect thereof in the course of management of trust fund or in relation to carrying out the objects and purposes of the trust as well as assets, credits and efforts of the trust.

5. POWERS OF THE TRUSTEES: -

For the furtherance of the objects, i.e., for propagation of education as mentioned in clause 3 the trustees will have the following powers, which will be exercised by them:

 To accept any donation, contributions, grant or subscriptions in cash or in kind from any person, body of persons or trust.

- b) To apply the whole or part of the income of the trust or accumulation thereof in whole or part of the corpus of the trust fund for any one or more of the objects of the trust as the trustees may, in their description from time to time, determine.
- c) To convert and deal with investments comprised in the trust fund and/or to carry the investment for the time being in the modes prescribed u/s.11 (5) of the I.T.Act, 1961.
- d) To invest and keep invested the trust fund either in the purchase or mortgage of immovable property including a flat or in units, shares, stocks, or debentures permitted by the Indian Trust Act, 1882 or any other statute, or deposit with banks, firms and to alter, vary or transpose such investments from time to time as the trustees may in their discretions think fit for others of the same or different nature.
- e) To borrow or rise or secure payment of money and also lend money either with or without security at the discretion of the trustees.
- f) To sell, dispose of alienate or otherwise deal with property belonging to the trust including property comprising the trust fund.
- g) To borrow money on behalf of the trust and charge the assets of the trust in respect of such liability incurred on behalf of the trust.
- h) To charge, convert or sell any of the trust's property, investment or assets including immovable property.
- To let out demise any immovable property of the trust for such period and at such rent and on such terms and conditions as the trustees in their discretions may think fit.

- j) To open accounts with any bank, operate such accounts and to give instructions to the banks and to provide for the opening and operation of such accounts by jointly with the 1st & 2nd Founder trustees of the Trust.
- k) To appoint constituted attorneys or agents and delegate to such attorneys or agents and delegate to such attorneys or agents all or any of the powers vested in them under these presents and from time to time remove such attorneys or agents and appoint other or others in his/her or their place.
- 1) To appoint or make provisions for the appointment of any person (including all or any of the trustees) as a committee of administrators or Founder Trustees or otherwise for the purpose of the administration of the trust in such manner and subject to such rules and regulations as the trustees may prescribed and also to appoint or provide for the appointment of separate trustees to hold any property or any funds or investment, subject to the provisions of this Deed, in such manner and subject to such rules and regulations as the trustees may from time to time think fit.
- m) To make, vary, alter or modify schemes, rules and regulations for carrying out the objects hereof and of having, any temple at any place in furtherance of the objects of the trust and otherwise for giving effect to the objects of the trust.
- n) To set apart or accumulate the whole or part of the income or corpus of the trust fund of part thereof for any subscription or donation made by them.
- o) To join, co-operate or amalgamate this trust with other or others having kindred or allied objects upon such terms and conditions as the trustees may in their discretion think fit particularly having regard to the objects and nature of this trust.

6. INDEMNITY: -

The trustees shall be chargeable only for such money, stocks, shares and funds as shall actually come in to their hands. A trustee shall not be answerable or accountable for neglect, default, acts of commission or omission of the other trustees nor of any banker or other person with whom the trust properties or any securities comprised in the trust fund have been deposited or kept.

The trustees herein shall stand indemnified against any act done in good faith and without negligence.

7. REMUNERATION TRUSTEES: -

The trustees will not be entitled to received any remuneration as trustee but may reimburse to themselves all expenses actually incurred by them in connection with the trust of their duties relating thereto.

The funds and the income of the trust shall be solely utilized for the achievement of its objectives and no portion of it shall be utilized for payments of the trustees by way of profit interest dividends, etc.

8. NUMBER OF TRUSTEES: -

The number of the trustees shall not be less than Four (4) including Managing Trustee & trustee of the Trust. The trustee shall not except for the purpose of filling any vacancy, act so long as the number is below the said minimum.
